# Upcoming Projects Handle with Care.

- Carla, Verne and Sabina will spearhead a Handle with Care Pilot Program for the Fayette County School District.
- "Handle with Care" provides the school with a "heads up" when a child has been identified by law enforcement at the scene of a traumatic event.

# **Narcan Training**

 The Southern Bluegrass CRP will host a Narcan Training. Other Child Welfare Providers and the public will be invited to attend. The Southern Bluegrass CRP will partner with the Substance Abuse and Violence Intervention SAVI Office, Amy to schedule a substance abuse training for the community.
