- O Members were updated on the planning of the Conversation on Collaboration. The conversation will comprise of two keynote speakers (30 mins. each), Dr. Shambra Mulder of Abundant Living-Psychological and Coaching Services and Neil Heffelbower of the Providence School in Wilmore, KY. Dr. Mulder will provide a brief overview of Trauma Informed Care. Neil will follow up by describing how the staff at the Providence School has been successful in connecting with students and meeting them where there are

 - How it impacts children and adults in social settings, schools, etc.? How it effects learning, behaviors, etc.?
 - Other important items identified
