Thank you for the comprehensive review completed on the issue of recidivism. Your analysis of this issue and your other work projects were extremely interesting. The report has been distributed and reviewed by staff throughout the Cabinet. Attached you will find our responses regarding these recommendations.

I appreciate the commitment of the Citizen Review Panel members in partnering with DCBS to work towards the goal of providing a safe and stable environment for the children and families of the Commonwealth. The Citizen Review Panel continues to provide DCBS with valuable insight into areas such as service delivery, collaboration, and advocacy that assist us in assessing the effectiveness of our service delivery system.

The Federal Child and Family Services Review statewide assessment was completed in March 2008. During June 16 – 20, 2008, the department participated in the required on-site review. Kentucky received their final report on April 13, 2009. On June 29, 2009 Kentucky submitted its five year child and family services plan and submitted its performance improvement plan on CFSR outcomes on July 10, 2009. The Citizen Review Panel has been incorporated into the plan under Theme 3 – Enhanced Community Collaboration. Your analysis on recidivism this past year will be invaluable as the Cabinet evaluates policies and practices relating to child maltreatment, in-home services and out-of-home care.

We appreciate your commitment to the work of the Citizen Review Panel and we look forward to continuing to work in partnership with each of you on behalf of the children and families of Kentucky.
